- 1. (U) THE PURPOSE OF THIS MESSAGE IS TO PROVIDE THE PLANNING AND EXECUTION GUIDANCE IN SUPPORT OF THE DIRECT EXCHANGE FOR THE SINCGARS RT'S LISTED IN PARAGRAPHS 1.A. AND 1.B. BELOW:
- 1.A. THESE RT'S ARE TO BE TURNED-IN USING THE PROCEDURES OUTLINED BELOW.

- 1.C. THE REPLACEMENT MODEL RT'S WILL BE ISSUED AT NO-COST TO THE RECEIVING UNITS. PRIOR TO THE EXCHANGE, UNITS WILL COMPLETE A 100 PERCENT INVENTORY TO ENSURE ALL ON-HAND RT'S ARE BROUGHT TO RECORD. THE INVENTORY IS NECESSARY IN ORDER TO ENSURE UNITS RECEIVE ALL AUTHORIZED RT'S EITHER AS DISTINCT MODIFIED TABLE OF ORGANIZATIONAL EQUIPMENT (MTOE) AUTHORIZED ITEMS OR AS COMPONENTS OF OTHER COMMUNICATIONS SYSTEMS NOT SEPARATELY LISTED ON THE MTOE.
- 1.D. THE SINCGARS RT'S ARE TO BE ACCOUNTED FOR IN PROPERTY BOOK UNIT SUPPLY ENHANCED/GLOBAL COMBAT SUPPORT SYSTEM-ARMY (PBUSE/GCSS-ARMY) UNDER PROPERTY BOOK IDENTIFICATION CODE (PBIC) 8 (MTOE), TYPE AUTHORIZATION CODE (TAC) 9 FOR MTOE UNITS. PBIC 4 TABLE OF DISTRIBUTION AND ALLOWANCES (TDA) AND TAC 9 WILL BE USED FOR TDA UNITS.
- 1.E. MODEL E AND F RT'S ARE TO BE ALIGNED UNDER THE CORRECT LIN AND NATIONAL ITEM IDENTIFICATION NUMBER (NIIN) AS LISTED IN PARAGRAPHS 1.A. AND 1.B. ABOVE. PROPERTY BOOK OFFICERS (PBO) ARE AUTHORIZED TO PROCESS A DA FORM 4949 TO REFLECT THE CHANGE OF THE ON-HAND RADIO SETS RESULTING FROM THE EXCHANGE (FOR EXAMPLE, CHANGE AN/VRC 92D LIN/NIIN TO AN/VRC 92F LIN/NIIN).
- 2. (U) THE QUANTITY OF RT'S EXCHANGED WILL NOT EXCEED WHAT IS ON THE UNIT'S MTOE PLUS THOSE ADDITIONAL RT'S THAT ARE COMPONENTS OF END ITEMS ALSO AUTHORIZED ON MTOE OR TDA.
- 2.A. ORGANIZATIONS THAT WERE DIRECTED TO LEAVE RT'S AS THEATER PROVIDED EQUIPMENT UPON REDEPLOYMENT ARE TO ANNOTATE THE SHORTAGES ON A DA FORM 2062 TO PROVIDE DOCUMENTATION IN SUPPORT OF THE PROGRAM MANAGER (PM) EXCHANGE OPERATION. AUTHORIZED RADIO SETS WITH RT SHORTAGES WILL BE FILLED UNDER THIS EXCHANGE PROGRAM.
- 2.B. IF RADIOS WITH RT SHORTAGES ARE NO LONGER AUTHORIZED, THE AFFECTED UNITS WILL NOT BE ISSUED THE REPLACEMENT RT MODELS TO FILL THE SHORTAGES.
- 2.C. EXCESS SERVICEABLE D MODEL RT'S IDENTIFIED DURING THE 100 PERCENT INVENTORY WILL BE CROSSLEVELED TO FILL SHORTAGES WITHIN OTHER COMMANDS.
- 3. (U) UNITS ARE REMINDED THAT RT'S ARE COMPONENTS OF END ITEMS (SINCGARS RADIOS). THEY ARE NOT SEPARATELY AUTHORIZED ON MTOE/TDA. THEY ARE REQUIRED TO BE ON RECORD IN ACCOUNTABLE SYSTEMS OF RECORD TO ADHERE TO NATIONAL SECURITY AGENCY REGULATORY REQUIREMENTS; IT IS NOT CONSIDERED DOUBLE ACCOUNTABILITY. PBO'S WILL RECORD THESE RT'S UNDER PBIC 8 (MTOE), TAC 9 AND PBIC 4 (TDA), TAC 9 IN PBUSE/GCSS-ARMY.

- 4. (U) ARMY COMMANDS (ACOM), ARMY SERVICE COMPONENT COMMANDS (ASCC), DIRECT REPORTING UNITS (DRU) AND THE ARMY NATIONAL GUARD (ARNG) WILL ONLY REPORT EXCESS RADIO SETS AND NOT EXCESS RT'S THROUGH THE AUTOMATED DECISION SUPPORT TOOL (DST). EXCESS RADIO SETS WILL BE IDENTIFIED IN DST BUT EXECUTION OF DISPOSITION INSTRUCTIONS IN PBUSE/GCSS-ARMY SHOULD INCLUDE BOTH THE RADIO SET AND RT LIN AND NSN. EXCESS RT'S WHICH ARE NOT ALIGNED TO ASSOCIATED RADIO SET REQUIREMENTS CAN BE TURNED-IN TO THE DESIGNATED LOCATION OUTLINED IN PARAGRAPH 9.B.6. DURING THE RT EXCHANGE PROCESS.
- 5. (U) VEHICLE AMPLIFIER ADAPTERS, POWER AMPLIFIER ADAPTERS AND TEST SET AN/GRM-122 ARE ALSO AVAILABLE FOR ISSUE TO UNITS AT NO-COST DURING THE EXCHANGE. ALL ACOM, ASCC, DRU AND THE ARNG MAY COORDINATE DIRECTLY WITH PM REPRESENTATIVE (MR. DAVE MANDLEY-LISTED IN PARAGRAPH 10.C) FOR THEIR RELEASE.
- 6. (U) ALL ACOM/ASCC/DRU AND THE ARNG WILL PROVIDE HQDA G-4/G-8 AND THE SINCGARS PM (LISTED IN PARAGRAPH 10.C) A LIST OF RT'S TO BE EXCHANGED IN THE ATTACHED FORMAT. ALSO DOCUMENT ANY SHORTAGES IN THE ATTACHMENT.
- 6.A. THIS LIST WILL BE REVIEWED AND ENDORSED BY HQDA G-4/G-8 PRIOR TO THE EXCHANGE. ACOM/ASCC/DRU'S AND THE ARNG SHOULD SUBMIT THEIR COMPLETED LISTS NO LATER THAN 14 CALENDAR DAYS PRIOR TO THE PM SCHEDULED EXCHANGE.
- 6.B. COMMANDS WILL PROCESS AND PROVIDE REQUEST FOR TAC AND FUNDS VERIFICATION USER AUTHORIZATION (FVUA) FORM FOR RETURN OF THE SINCGARS RT TO USARMY.APG.CECOM.MBX.LRC-LEO-MAJOR-ITEM-SDT-SHIPMENT-REQUESTS@MAIL.MIL. COMMANDS ARE NOT AUTHORIZED TO SHIP ASSETS USING THE CECOM TAC UNTIL THEY HAVE RECEIVED THE APPROVED CECOM FVUA FORM.
- 7. (U) ACOM/ASCC/DRU'S AND THE ARNG WILL CONTACT TOBYHANNA DLA POINT OF CONTACT (POC), TED NELSON VIA E-MAIL: THEARDIS.NELSON@DLA.MIL OR COMMERCIAL (570) 615-7691 PRIOR TO SHIPMENT TO ENSURE THE DEPOT IS PREPARED FOR THE VOLUME OF ASSETS TO BE RECEIVED.
- 8. (U) THERE ARE TWO OPTIONS AVAILABLE TO THE COMMANDS TO CONDUCT THE RT EXCHANGE:
- 8.A. OPTION ONE-DIRECT FIELDING (ISSUED BY PM VIA LATERAL TRANSFER THROUGH PBUSE OR TO GCSS-ARMY (IF UNIT IS ON WAVE 2)) AT THE BRIGADE OR BRIGADE EQUIVALENT LEVEL. UNITS WILL BE RESPONSIBLE TO FURTHER DISTRIBUTE AND DOCUMENT THE RT'S TO THE AUTHORIZED SUBORDINATE UNITS.
- 8.B. OPTION TWO-DIRECT SHIPMENT TO A DESIGNATED SUPPLY SUPPORT

ACTIVITIES (SSA).

- 8.C. ACOM/ASCC/DRU'S AND THE ARNG MAY IDENTIFY THE OPTION THEY PREFER WHEN THEY SUBMIT THEIR LISTS FOR VALIDATION REFERENCED IN PARAGRAPH 6.
- 8.D. THE SINCGARS PM IS EXEMPT FROM THE GUIDANCE (FIELDING) OUTLINED IN AR 700-142 FOR THIS RT EXCHANGE ONLY.
- 9. (U) THE RT EXCHANGE WILL BE CONDUCTED IN TWO PHASES:
- 9.A. PHASE ONE-IDENTIFICATION AND VERIFICATION OF ACOM/ASCC/DRU'S AND THE ARNG RT REQUIREMENTS.
- 9.A.1. HQDA G-4/G-8 AND PM SINCGARS WILL IDENTIFY AND VERIFY THE QUANTITIES OF THE NUMBER OF A AND D MODEL RT'S. PM SINCGARS WILL INITIATE CONTACT WITH THE GAINING ACOM/ASCC/DRU'S AND THE ARNG ARMY, G-4 DESIGNATED POC.
- 9.A.2. COMMAND POCS WILL PROVIDE THE SSA'S DEPARTMENT OF DEFENSE ACTIVITY ADDRESS CODE, SHIPPING INFORMATION, AND CENTRAL RECEIVING POINT FOR THE TURN-IN AND REPLACEMENT OF RT'S.
- 9.B. PHASE TWO-ONE FOR ONE EXCHANGE OF RT-1523, RT-1523A, RT-1523B, RT-1523C AND RT-1523D FOR NEW MODEL RT-1523E, RT-1523F AND RT-1523G.
- 9.B.1. PM SINCGARS WILL INITIATE ALL SHIPMENTS BASED ON PRIOR COORDINATION WITH THE COMMANDS. SSA DESIGNATED REPRESENTATIVES WILL SIGN FOR THE RT'S ON A DD FORM 1348 AND RETURN THE SIGNED FORM BACK TO PM SINCGARS WITHIN SEVEN CALENDAR DAYS.
- 9.B.2. ALL RT'S WILL BE ACCOUNTED FOR IN GCSS-ARMY (WAREHOUSE) WHILE RESIDING IN THE SSA.
- 9.B.3. UNITS WILL TURN-IN THEIR RT-1523, RT-1523A, RT-1523B, RT-1523C AND RT-1523D TO THE SSA ON A PBUSE/GCSS-ARMY GENERATED TURN-IN DOCUMENT (DD FORM 1348) IN EXCHANGE FOR THE NEW MODEL RT-1523E, RT-1523F AND RT-1523G.
