2. (FOUO) THIS MESSAGE CLARIFIES ARMY IMMEDIATE RESPONSE REPORTING REQUIREMENTS DELINEATED IN DOD DIRECTIVE 3025.18.
3. (FOUO) IN ORDER TO CLARIFY REPORTING REQUIREMENTS IN REF A, PARAGRAPH 4.G.(1), EFFECTIVE IMMEDIATELY, WHEN OPERATIONAL (MTO&E/NON-GARRISON) RESOURCES ARE USED IN AN IMMEDIATE RESPONSE ROLE, (THIS INCLUDES MUTUAL AID AS DEFINED IN DODD 3025.18) NO LATER THAN 2 HOURS AFTER THE RESPONSE IS INITIATED, THE DOD OFFICIAL DIRECTING THE RESPONSE UNDER IMMEDIATE RESPONSE AUTHORITY SHALL NOTIFY THE ARMY OPERATIONS CENTER, AND SIMULTANEOUSLY NOTIFY (CC:) THE HQDA G-34 ARMY DOMESTIC SUPPORT DIVISION. THIS REPORTING REQUIREMENT DOES NOT APPLY TO MUTUAL AID ACTIONS BY FIRE AND EMERGENCY SERVICES.
