- 1. (FOUO) SITUATION. THE ARMY CONSOLIDATES CRC OPERATIONS FROM FT. BENNING, GA (FBGA) AND THE USACE DEPLOYMENT CENTER (UDC), WINCHESTER, VA TO FT BLISS, TX (FBTX) NLT 01 OCT 2013.
- 2. (FOUO) MISSION. THE ARMY ESTABLISHES AN ENDURING CRC FOR NON-UNIT RELATED PERSONNEL (NRP) AT FBTX NLT 01 OCT 2013 WHILE TEMPORARILY SUSTAINING THE NON-LOGCAP CONTRACTOR DEPLOYMENT MISSION AT CAIN TO FACILITATE AN EFFICIENT CONSOLIDATION.
- 3. (FOUO) EXECUTION.
- 3.A. (FOUO) EFFECTIVE 09 AUG 2013, THE CRC AT FBGA MOVES TO FBTX. CRC-BENNING WILL NO LONGER ACCEPT RESERVATIONS OR PROCESS DEPLOYING/RE-DEPLOYING NRP AFTER 09 AUG 2013. FBGA CRC WILL CEASE ALL OPERATIONS ON 31 AUG 2013.
- 3.A.1. (FOUO) EFFECTIVE 09 AUG 2013, ALL NRP MILITARY, DEPARTMENT OF THE ARMY CIVILIANS (DACS), EMPLOYEES OF THE AMERICAN RED CROSS (ARC) AND ARMY AIR FORCE EXCHANGE SERVICE (AAFES) WILL PROCESS THROUGH THE NEW CRC AT FBTX. THE EXCEPTION TO THIS WILL BE USACE SOLDIERS AND DACS WHO WILL PROCESS FOR DEPLOYMENT AND REDEPLOYMENT AT UDC UNTIL 26 SEP 2013.

AND DACS WILL REDEPLOY AND OUT-PROCESS AT CRC-BLISS.

- 3.A.3. (FOUO) DUE TO A LACK OF KENNEL SPACE FOR MILITARY WORKING DOGS (MWD) AT CRC-BLISS; MWDS WILL NOT TRAVEL TO CRC-BLISS. MWD HANDLERS WILL RETURN TO HOME STATION AFTER CRC VALIDATION AND DEPLOY WITH THEIR MWD IN ACCORDANCE WITH REF D, PARAGRAPH 3.C.22.
- 3.A.4. (FOUO) EFFECTIVE 26 SEP 2013, THE UDC MILITARY AND DAC PERSONNEL WILL PROCESS FOR DEPLOYMENT FROM CRC-BLISS. THE UDC WILL CEASE CRC-TYPE OPERATIONS AT WINCHESTER, VA BY 30 SEP 2013.
