MARKINGS AND SYMBOLS, INCLUDING THE SPECIFIC C-A-T NATIONAL STOCK NUMBER (NSN), CAN BE SIMILAR OR IDENTICAL. THERE ARE SEVERAL REPORTS THAT THESE COUNTERFEIT DEVICES ARE OF INFERIOR DESIGN AND QUALITY AND MAY CAUSE SERIOUS INJURY OR DEATH.
