SUBJECT/ALARACT 260/2014: SUPPLEMENTAL GUIDANCE FOR FEMALE STUDENTS AND UNITS FOR THE UNITED STATES ARMY MCOE RANGER COURSE ASSESSMENT

NARR/(U) PURPOSE OF THIS MESSAGE IS TO PROVIDE ADDITIONAL GUIDANCE TO UNITS THAT SUBMITTED NUMBERS OF POTENTIAL RANGER COURSE ASSESSMENT STUDENT PARTICIPANTS IN ACCORDANCE WITH (IAW) ALARACT 222/2014.

- 1. (U) BACKGROUND: AS PART OF THE ARMY SOLDIER 2020 INITIATIVE TO ENSURE THE BEST-QUALIFIED SOLDIERS HAVE THE OPPORTUNITY TO SERVE IN ANY POSITION WHERE THEY ARE CAPABLE OF PERFORMING TO STANDARD, THE MCOE MAY CONDUCT A SINGLE COURSE ASSESSMENT OF THE RANGER COURSE IN 3RD QTR FY15 WITH BOTH MALE AND FEMALE STUDENTS (DECISION REGARDING EXECUTION OF THE ASSESSMENT WILL BE MADE ON/ABOUT JANUARY 2015).
- 1.A. (U) IAW ALARACT 222/2014, UNITS WERE REQUIRED TO PROVIDE US ARMY INFANTRY SCHOOL (USAIS) THE NUMBER OF POTENTIAL RANGER COURSE ASSESSMENT PARTICIPANTS NO LATER THAN (NLT) 3 NOVEMBER 2014.
- 1.B. (U) REQUESTS FOR TRAINING SEATS FROM ARMY COMMANDS (ACOMS), ARMY SERVICE COMPONENT COMMANDS (ASCCS), DIRECT REPORTING UNITS (DRUS), AND IDENTIFIED COMMANDS EXCEEDED THE NUMBER OF FEMALE STUDENT TRAINING SEATS AVAILABLE FOR THE RANGER COURSE ASSESSMENT. THIS ALARACT MESSAGE WILL PROVIDE SUBMITTING UNITS THEIR ALLOCATION OF TRAINING SEATS FOR STUDENT VOLUNTEERS, IF THE DECISION TO CONDUCT THE ASSESSMENT IS MADE.
- 2. (U) RANGER COURSE ASSESSMENT POINTS OF CONTACT (POCS).
- 2.A. RANGER COURSE ASSESSMENT POCS WILL BE RESPONSIBLE FOR CONSOLIDATING, MANAGING, COORDINATING, PREPARING, AND SUBMITTING STUDENT AND COURSE INFORMATION ON BEHALF OF THEIR COMMAND.

- 4.B. (U) ACOMS, ASCCS, DRUS, AND IDENTIFIED COMMANDS WILL USE RTAC PERFORMANCE AS A CRITERION WHEN SELECTING THEIR STUDENT PARTICIPANTS TO FILL THEIR ALLOCATED TRAINING SEATS FOR THE RANGER COURSE ASSESSMENT.
- 4.C. (U) RTAC TRAINING SEATS ARE DISTRIBUTED ACROSS THE ACOMS, ASCCS, DRUS, AND IDENTIFIED COMMANDS IAW THEIR INITIAL SUBMISSIONS PROVIDED TO USAIS ON 3 NOVEMBER 2014.

- 5.B. (U) ALL RANGER COURSE ASSESSMENT STUDENTS ARE REQUIRED TO COMPLETE THE ATTACHED SERVICE SCHOOL WORKSHEET. THE SERVICE SCHOOL WORKSHEETS WILL BE SIGNED BY THE FIRST LIEUTENANT COLONEL (LTC)/O-5 IN THE STUDENT'S CHAIN OF COMMAND.
