2. PURPOSE: YOUR IMMEDIATE SUPPORT IS NEEDED ON THIS MATTER. THE

SOLDIERS IN A HIGHER OML CATEGORY ATTEND WLC.

4. EFFECTIVE 1 OCTOBER 2014:

A. NO SGT (E-5) WILL BE ENROLLED IN ALC RESIDENCE PHASE UNTIL  
COMPLETION OF ALC-CC OR SSD 2.

B. SGTS (E-5) SCHEDULED OR HAVE A RESERVATION IN ALC RESIDENCE  
PHASE, BUT NOT IN ATTENDANCE, WILL BE REMOVED FROM THE CLASS  
AND RESCHEDULED FOR A LATER CLASS TO ALIGN WITH COMPLETION OF  
SSD 2, PRIOR TO ATTENDING THEIR RESPECTIVE ALC RESIDENCE PHASE.

5. AS WE TRANSITION FROM AN ARMY OF EXECUTION TO AN ARMY OF PREPARATION, IT IS IMPERATIVE THAT COMMANDERS AT ALL LEVELS ENSURE OUR NCOS ATTEND PME IN ACCORDANCE WITH ESTABLISHED DEVELOPMENTAL TIMELINES. THE PME ATTENDANCE IS ESSENTIAL TO OUR LEADER DEVELOPMENT PROCESS AND WILL POSITIVELY IMPACT OUR NCO'S EFFECTIVENESS AT ALL LEVELS OF ASSIGNMENT. FAILURE TO ATTEND PME ON TIME CAN NEGATIVELY IMPACT A NCO'S CAREER.
