- 2. THIS MESSAGE PROVIDES CLARIFYING GUIDANCE FOR EFFECTIVE DATES OF SIGNIFICANT CHANGES ANNOUNCED IN AR 670-1 AND DA PAM 670-1.
- 3. SOLDIERS MUST ADHERE TO NEW GROOMING STANDARDS, AS OUTLINED IN PARAGRAPH 3-2 OF AR 670-1, NO LATER THAN 7 DAYS FROM THE RELEASE OF AR 670-1.
- 4. SOLDIERS MUST INITIATE REMOVAL OF UNAUTHORIZED DENTAL ORNAMENTATION IAW PARAGRAPH 3-4F NO LATER THAN 60 DAYS FROM THE RELEASE OF AR 670-1.
- 5. SOLDIERS MUST ADHERE TO ALL OTHER JEWELRY STANDARDS AS OUTLINED IN PARAGRAPHS 3-4A THROUGH 3-4E UPON RELEASE OF AR 670-1.
- 6. CURRENTLY SERVING SOLDIERS ARE PROHIBITED FROM OBTAINING NEW TATTOOS THAT DO NOT MEET THE CRITERIA OUTLINED IN PARAGRAPH 3-3 OF AR 670-1 UPON RELEASE OF AR 670-1. SOLDIERS NOT GRANDFATHERED (FOR EXAMPLE, A SOLDIER WITH A HEAD OR FACE TATTOO OR A TATTOO WHICH IS EXTREMIST, INDECENT, SEXIST OR RACIST) AND THEREFORE NOT IN COMPLIANCE MUST BE PROCESSED IAW PARAGRAPH 3-3H. COMMANDERS MUST INITIATE THIS PROCESS NO LATER THAN 30 DAYS FROM THE RELEASE OF AR 670-1.
- 7. APPLICANTS CONTRACTED FOR SERVICE IN ANY U.S. ARMY COMPONENT OR ENROLLED IN ANY ACCESSION PROGRAM BEFORE OR CONTRACTED/ENROLLED WITHIN 30 DAYS AFTER THE DATE OF RELEASE OF AR 670-1 ARE GRANDFATHERED TO THE PREVIOUSLY PUBLISHED TATTOO/BRANDING POLICY. AFTER 30 DAYS, APPLICANTS MUST ADHERE TO THE STANDARDS PUBLISHED PARAGRAPH 3-3 OF AR 670-1.
- 8. ENLISTED SOLDIERS SELECTED BEFORE 1 JULY 2014 BY SELECTION BOARDS OR OTHER SELECTION PROCESSES FOR OFFICER ACCESSION PROGRAMS ARE ALSO GRANDFATHERED TO THE PREVIOUSLY PUBLISHED

TATTOO/BRANDING POLICY.

- 9. COMMANDERS OF ACTIVE DUTY SOLDIERS MUST COMPLETE TATTOO VALIDATION MEMOS (WITH PHOTOS AS ENCLOSURES) FOR ALL ASSIGNED SOLDIERS AS OUTLINED IN PARAGRAPH 3-3E OF AR 670-1 WITHIN 30 DAYS UPON RELEASE OF AR 670-1. MEMORANDUMS WITH PHOTOS MUST BE WEB UPLOADED TO IPERMS BY RECORDS MANAGERS FOR FILING INTO SOLDIERS' ARMY MILITARY HUMAN RESOURCE RECORD WITHIN 60 DAYS UPON RELEASE OF AR 670-1.
- 10. COMMANDERS OF RESERVE COMPONENT UNITS MUST COMPLETE TATTOO VALIDATION MEMOS (WITH PHOTOS AS ENCLOSURES) FOR ALL ASSIGNED SOLDIERS AS OUTLINED IN PARAGRAPH 3-3E OF AR 670-1 WITHIN 120 DAYS UPON RELEASE OF AR 670-1. MEMORANDUMS WITH PHOTOS MUST BE WEB UPLOADED TO IPERMS BY RECORDS MANAGERS FOR FILING INTO SOLDIERS' ARMY MILITARY HUMAN RESOURCE RECORD WITHIN 150 DAYS UPON RELEASE OF AR 670-1.
- 11. ACCESSION DETERMINATION AUTHORITIES, AS OUTLINED IN PARAGRAPH 3-3I OF AR 670-1, WILL ENSURE ALL CURRENT APPLICANTS WHO ARE CONTRACTED/ENROLLED FOR SERVICE HAVE THEIR TATTOOS/BRANDS VALIDATED WITHIN 30 DAYS UPON RELEASE OF AR 670-1.
- 12. SOLDIERS MUST COMPLY WITH THE REOUIREMENT (OUTLINED IN PARAGRAPH 4-8E OF DA PAM 670-1) TO SEW ON THE NAME TAPE, U.S. ARMY TAPE, AND GRADE INSIGNIA WHEN BADGES ARE SEWN ON (THE COMBAT UNIFORM) NO LATER THAN 7 DAYS UPON RELEASE OF DA PAM 670-1. ADDITIONALLY, IF A NAMETAPE, U.S. ARMY TAPE OR GRADE INSIGNIA IS SEWN ON THE COMBAT UNIFORM, THEN PERSONNEL MUST SEW ALL THREE OF THESE ITEMS ON THE UNIFORM COAT. THIS ALSO APPLIES TO OTHER UNIFORM ALTERATIONS, WHICH REQUIRE SEWING. 13. APPLICABLE PERSONNEL MUST WEAR NOMINATIVE SENIOR ENLISTED LEADER COLLAR INSIGNIA (PREVIOUSLY REFERRED TO AS CSM INSIGNIA) IAW PARAGRAPH 21-9I OF DA PAM 670-1 NO LATER THAN 30 DAYS FROM RELEASE OF AR 670-1. COMMAND SERGEANTS MAJOR AND SERGEANTS MAJOR REQUIRED TO CHANGE THEIR COLLAR INSIGNIA MUST UPDATE THEIR DA PHOTO NO LATER THAN 12 MONTHS FROM RELEASE OF DA PAM 670-1. THIS ALSO APPLIES TO CSMS WORKING FOR O-6 AND BELOW WHO WILL NOW WEAR DESIGNATED BRANCH INSIGNIA.
- 14. NONCOMMISSIONED OFFICERS MUST WEAR SHOULDER MARKS (GRADE INSIGNIA) ON THE SHOULDER LOOPS OF THE BLACK ALL-WEATHER COAT AND WINDBREAKER IAW PARAGRAPHS 20-7 AND 20-30 OF DA PAM 670-1 NO LATER THAN 30 DAYS FROM RELEASE OF AR 670-1.
- 15. APPLICABLE PERSONNEL MUST WEAR COMBAT AND SPECIAL SKILL BADGES AND SPECIAL SKILL METAL TAB REPLICAS ON COMBAT, SERVICE, AND DRESS UNIFORMS IAW PARAGRAPH 22-16 OF DA PAM 670-1 NO LATER THAN 30 DAYS FROM RELEASE OF AR 670-1. SOLDIERS REQUIRED TO

CHANGE THE PLACEMENT OF SUCH ITEMS ON THEIR SERVICE UNIFORM MUST UPDATE THEIR DA PHOTO NO LATER THAN 12 MONTHS FROM RELEASE OF DA PAM 670-1.

- 16. ALL OTHER CHANGES CONTAINED IN AR 670-1 AND DA PAM 670-1 AND NOT OTHERWISE ADDRESSED IN THIS MESSAGE MUST BE ADHERED TO UPON RELEASE OF THESE PUBLICATIONS.
- 17. LEADERS AT ALL LEVELS WILL PLAY A VITAL ROLE IN EDUCATING SUBORDINATES AND ENFORCING STANDARDS SET FORTH IN THESE PUBLICATIONS. EVERY LEADER SHOULD TAKE A COMMON SENSE APPROACH TO THE NEW POLICIES AND ENSURE SOLDIERS UNDERSTAND AND ADHERE TO THE POLICIES IN A TIMELY MANNER.
