MISSION ORDER

(U) TASK ORGANIZATION: (Deliberate Attack #1, 1st SQD)

1 PLT/B CO/2-156 IN 1st SQD, 2nd SQD, 3rd SQD, WPNs SQD

1. (U) SITUATION:

a. Area of Interest: Donovia and Atropia are based in the Caucasus region (Fort Bragg) between Europe and Asia. Donovia invaded and seized the city of Razish, causing a disruption in the area’s export of hydrocarbon resources. 2-156 IN is assisting the Atropia government to restore stability to the region and protect the interests of the United States.

b. Area of Operation: Intelligence reports that the Bilasuvar Freedom Brigade (BFB) insurgents supported by the Donovia Military are using local roads around Sumgayit Village to establish weapons caches in preparation for the planned United States (US) operations in support of the Atropia Government. The Atropia Government has requested US assistance in interdicting BFB fighters and weapons flowing into the Sumgayit Area of Operations (AO).

BSA Bragg VIC PU 7683 9611, GBOSS reports suspicious activity at the Compounds IVO PU 7486 9995 and PU 7471 9944 due to increased foot traffic during hours of limited visibility along an area of established trails and dirt roads. New intelligence indicates that the locals from the Sumgayit village avoid this area. S-2 sources state that Sumgayit locals have been instructed by the BFB insurgents to stay clear of that compound.

c. Enemy Forces: The BSA insurgents controlling this area have a history of building short term caches in close proximity to the MSR and ASR used by coalition forces. These caches are sometimes assembled up to three months prior to use and can contain materials for the construction of multiple IEDs. The insurgents will sometimes incorporate assembled VOIEDs or military grade anti-personnel mines to protect their

caches. The compound to the East of ASR Oregon is located within the area of recent IED activity that has occurred in the past 60 days.

d. Friendly Forces: Mission and Intent 2 levels up / Adjacent Units

Mission: 2-156 IN Conduct Wide Area Security operations on 110001JUN2015 in the VIC of Sumgayit Village IOT to support the Atropia government fight the BFB.
Intent: Secure Surngayit Village in support of the Atropia Government.

Mission: B CO/2-156 IN conduct deliberate attack vicinity grid PU 7486 9995 on 101500JUN2015 IOT to seize compound (OBJ Black and Gold) and interdict BFB fighters and weapons cache.
Intent: My intent is to ensure the target compounds and caches are secured to deny resources to BFB forces. (See Company Graphic)

Company ME / 2 PLT/B CO/2-156 IN conduct deliberate attack vicinity grid PU 7486 9995 on 101500JUN2015 IOT to seize compound (OBJ Gold) and interdict BFB fighters and weapons cache.

Company SE1 / 1 PLT/B CO/2-156 IN conduct deliberate attack vicinity grid PU 7471 9944 on 101500JUN2015 IOT to seize compound (OBJ Black) and interdict BFB fighters and weapons cache.

Company SE2 / 3 PLT/B CO/2-156 IN occupy blocking positions East of OBJ Black and Gold NET 101400JUN2015 to prevent enemy forces from influencing the company main effort. 3rd SQD/ 3 PLT will be the company reserve and one squad will be co-located with the company mortars.

Company SE3 / 3 PLT/A CO/2-156 IN occupy blocking positions North of OBJ Black and Gold NET 101400JUN2015 to prevent enemy forces from influencing the company main effort.

Company SE4 / 2 PLT/C CO/2-156 IN occupy blocking positions North of OBJ Black and Gold NET 101400JUN2015 to prevent enemy forces from influencing the company main effort.

Company 60-mm mortars will be located at vicinity grid PU 7525 9971.

e. Attachments and Detachments: N/A

2. (U) MISSION: 1 PLT/B CO/2-156 IN conduct deliberate attack vicinity grid PU 7471 9944 on 101500JUN2015 IOT to seize compound (OBJ Black) and interdict BFB fighters and weapons cache.

3. (U) EXECUTION:

a. Intent. My intent is to conduct a Deliberate Attack at the target compound to locate and secure the weapons cache IOT deny resources to the BFB forces with no friendly force casualties. Due to recent IED activity IVO OBJ Black, all platoon elements will ensure that they are using C-IED TTPs to mitigate the IED threat.

b. Concept of the Operation: This operation will consist of eight phases.
Phase I: Planning, Operations Order, PCIs/PCCs, back-briefs and rehearsals.
Phase II: Ground Convoy Movement to PU 7525 9971.

Phase III: Conduct dismounted movement from truck dismount point to Release Point (RP)

Phase IV: 3rd, 2nd, and WPN's Squad (w/attachments) will occupy Blocking Positions and SBF to isolate objective.

Phase V 1st PLT conduct Deliberate Attack on OBJ Black, conduct Consolidation and Re-organization.

Phase VI: PLT will conduct phased withdrawal from OBJ (1st SQD, 2nd SQD, 3rd SQD, Mortars) to Company RP.

Phase VII: Convoy Back to BSA Bragg.

Phase VIII: Conduct debrief at BSA Bragg.

Phase I will be executed at the Squad level in accordance with the established PLT SOP and timeline.

Phase II 1st PLT on completion of PLT and SQD rehearsals will move to Convoy Staging area on BSA Bragg and conduct ground movement to (PU 7525 9971) located East of Sumgayit village. (see concept of the operation graphics) The convoy PRI and ALT route will be briefed to the PL.

Phase III, 1st PLT will conduct tactical movement from truck dismount point to PLT RP.

Phase IV, all elements will continue movement from release point (RP) utilizing dismounted maneuver TTPs to their designated position. 2nd SQD and 3rd SQD will move dismounted to their respective security positions. After reaching their respective blocking positions, 2nd SQD and 3rd SQD will secure and clear the area against all potential enemy threats, with special attention to IEDs within their blocking position, and PBIEDs and SVBIEDS. While in the blocking positions 2nd SQD and 3rd SQD will prevent any elements including enemy and/or civilian from moving into or out of the area surrounding OBJ Black. 2nd SQD and 3rd SQD will hold their position until completion of the Deliberate Attack.

Phase V: WPNs SQD and 2nd SQD (-) will move to and clear a Support by Fire (SBF) position to the east of OBJ Black. The BFB have been known to use IED belts in close proximity to HVT locations and WPN SQD and 2nd SQD (-) will have to mitigate this potential threat while occupying the SBF position.

1st SQD will move to an Assault Position (ASLT POS) East of OBJ Black.

Phase VI: Once security has been established (3rd SQD and 2nd SQD (-)), the SBF has been cleared and occupied (WPNs SQD and 2nd SQD (-)), 1st SQD will isolate the compound to mitigate the CWIED threat on the north and western sides, followed by gaining entry to the compound and clearing OBJ Black of possible enemy threats and to locate the weapons caches. Upon clearing OBJ Black and locating the weapons cache, 1st SQD will consolidate and reorganize on the OBJ.

Phase VII: Higher will initiate a withdrawal of all friendly elements from the OBJ Black beginning with all 1st SQD, 2nd SQD, and then the two security elements. All PLT elements will move back to the PLT RP located and then conduct dismounted movement to the company extraction point.

Phase VIII: Will start upon arriving at BSA Bragg, all PLT elements will move to S-2 building to conduct de-briefing.

c. Scheme of Maneuver:

As soon as the PLT dismounts from the convoy we will move to the PL RP. From the PLT RP, each SQD / element will move independently to their assigned position. Each SL will provide the PL with that SQD's planned maneuver route including azimuths and distances that will be used. Security element leaders (2nd SQD and 3rd SQD) will need to

brief the PL on how they plan to clear and occupy their blocking positions. WPN SQD leader will also brief the PL on how he plans on clearing and occupying the SBF position. 1st Squad Leader will need to brief how they plan to mitigate the IED threats at OBJ Black and clear the compound. Due to the rise of IEDs in the area around the OBJ Black, SQDs will employ Dismounted Counter-IED Tactics to clear each blocking position, SBF, and the OBJ Compound. Squad Leaders will brief the PL on their plan to mitigate the small arms fire threat and in detail how they will clear their assigned area of the IED threat. Once Blocking Positions are cleared, 2nd SQD and 3rd SQD will occupy and hold their blocking position. At the conclusion of Phase VI each SQD needs to BPT execute a dismounted movement back to PLT RP IOT to link up with other friendly elements and conduct company movement back to BSA Bragg.

Additional details that must be planned and briefed by SL to the PL: ORP, Pin point OBJ, Platoon Blocking Positions/security and SBF clearing and occupation plans, RP locations, 1st SQD Tactical callout plan, Plans for both an occupied compound search and an un-occupied compound search (Isolation, Clear Approach, Clear Entry (ground level exit/linked into cleared area, Compound Search) Actions on contact, actions on IED find, withdrawal plan from OBJ, and plan to collapse the Blocking Positions.

d. Scheme of Fires: Purpose of fires is to fix enemy forces in contact with coalition forces. PLT 60-mm mortar will be located at PU 7525 9971. Priority of fires is to unit in contact and must be observed. A restricted fire area (RFA) is established 400 meters around urban areas.

e. Casualty Evacuation: Ground evacuation to BSA Bragg and Air CASEVAC available upon request. Level-2 medical facility located at the Port of Baku (Main Post Fort Bragg). All units will have a plan and rehearse to secure and clear PZs for air CASEVAC.

f. Task to Subordinate Units

1st SQD: ME Task- Conduct Deliberate Attack VIC PU 7471 9944, Purpose- IOT deny resources to the BFB by locating possible weapons cache in the compound.

WPN SQD and 2nd SQD (-): SE1 Task- Occupy SBF VIC 4010 1388, Purpose- IOT to prevent enemy forces from influencing the PLT main effort.

3rd SQD: SE2 Task- Occupy Blocking Position VIC ET PU 7475 9957, Purpose- IOT to prevent enemy forces from influencing the PLT main effort.

2nd SQD (-): SE3 Task- Occupy Blocking Position at VIC PU 7458 9938, Purpose- IOT to prevent enemy forces from influencing the PLT main effort.

g. Coordinating Instructions: All Squads will conduct mission planning (TLPs) on receipt of this order. SL will brief their Squad time line and understanding of their Task and Purpose to PL prior to Mission Analysis. SL will conduct a back-brief upon completion of Platoon OPORDER. Squads will also conduct (FULL FORCE) rehearsals, PCC/PCIs, and Squad Brief Backs prior to SP/LD.
