1. THERE IS AN INSUFFICIENT INVENTORY OF THE RRPR FOR MLRS/HIGH MOBILITY ARTILLERY ROCKET SYSTEM TRAINING IN FY16. THIS SHORTFALL WILL EFFECT THE ABILITY OF SOME UNITS TO PERFORM ALL OF THEIR MISSION ESSENTIAL TASK LIST RELATED TO LIVE FIRE MISSIONS.
2. THIS ALIGNS AUTHORIZATIONS WITH REQUIRED READINESS LEVELS. COMMANDS WILL PRIORITIZE THEIR TRAINING USING THE PROVIDED RRPRS. REDUCTION FOR CONUS COMMANDS RRPRS AUTHORIZATIONS WILL BE (FROM/TO): FORSCOM (1296 / 1296); NGB (896 / 324); G-3 SOD (200 / 160); 1ST ARMY (132 / 106); AND TRADOC (144 / 116).
3. USARPAC WILL TRAIN AT A FREQUENCY OF ONE FOR TABLE XII, XV, AND XVIII EVENTS FOR EACH USARPAC ROTATIONAL BATTALIONS IN FY16. EACH USARPAC ROTATIONAL BATTALION RECEIVES LIVE FIRE TRAINING PRIOR TO ROTATING INTO USARPAC. USARPAC PERMANENT STATIONED MLRS UNITS WILL TRAIN AT FULL STRAC. THIS CHANGES THE USARPAC AUTHORIZATIONS FOR RRPRS FROM 432 TO 368.
4. THIS SHORTFALL IS PREDICTED TO ONLY IMPACT FY16. FULL STRAC AUTHORIZATIONS ARE EXPECTED FOR FY17.
